## REPORT

A visit for the observation of Juvenile Justice Board at Feroz Shah Kotla, Delhi (Under supervision Ministry of Women & Children, Delhi Government) and its system was organised on 12<sup>th</sup> September '19 wherein 20 volunteers went to the juvenile jail. The Juvenile Justice Board is working since 2003 in New Delhi

The visit was conducted under the kind supervision of **Dr. Pallavi Gupta** and **Mr. Manvendra Singh**.

### **Observation:**

The volunteers interviewed the juveniles who were guilty or were charged for the crimes such as murder, half murder, theft, and severe hurt. The volunteers also examined that the juveniles were allowed to call their family on every Friday for the duration of maximum 15 minutes the volunteers also observe that some of the children were addicted in the clutches of intoxication and drug. During the observation the mental state of the juveniles was reflected by guilt in the most of the cases and justification of action in others.

### **Motive:**

The main motive of the board is to counsel and create a healthy lifestyle for the juveniles in order to eliminate crime from their minds. There were various activities available such as painting; sketching, storytelling and the creative aspect of their minds are appreciated by encouraging music and sports. The infrastructure was in an average and acceptable state with the availability of coolers, personal lockers, fans, beds, and a playground. The authorities provide quality food and attend to their basic necessities.
