2. Counselling Procedure:

2.1. All the above mentioned candidates are required to report in person along with documents mentioned herein to the Institute for counseling process at 10:00 AM on 26th August 2023.

2.2. On reaching the venue, the candidates must mark the Attendance available with the Admission Officer. Allotment of Management Quota seat will be made to a candidate only when he/she attends the counselling session in person.

2.3. The candidates will be called in the order of merit. A candidate who fails to appear in person on the notified venue, date and time for counselling shall forfeit his/her claim for the seat which would have been offered to him/her had he/she been present on his/her turn.

2.4. A candidate who is alloted a seat will be required to pay a notified fee immediately on the spot at the time of counseling/admission. If a candidate, fails to pay the fee as mentioned above immediately after the seat is offered to him/her, the offer will be withdrawn on the spot and the seat will be offered to the next candidate in the merit list.
