Counselling Procedure:

1. All the candidates are required to report in person along with documents mentioned herein to the Institute for counselling process at 10:00 AM on 7/11/2022 at Jims Greater Noida, Building AB2, Room No. 102
2. On reaching the venue, the candidates must mark the Attendance available with the Admission Officer. Allotment of Management Quota seat will be made to a candidate only when he/she attends the counselling session in person.

3. The candidates will be called in the order of merit. A candidate who fails to appear in person on the notified venue, date and time for counselling shall forfeit his/her claim for the seat which would have been offered to him/her had he/she been present on his/her turn.
4. A candidate who is allotted a seat will be required to pay a notified fee immediately on the spot at the time of counselling/admission. If a candidate fails to pay the fee as mentioned above immediately after the seat is offered to him/her, the offer will be withdrawn on the spot and the seat will be offered to the next candidate in the merit list. Part payment will not be accepted under any circumstances.
- 5 All the admissions in the Management Quota shall be provisional till regularized by the University.


Candidates shall bring the following documents for verification

1. Proof of registration for Management Quota Seat applied on GGSIP University portal.
2. JEE Admit Card (Original & Photocopy).
3. Copy of Rank in JEE.
4. Original Certificates and Mark Sheet of qualifying examination along with three self-attested photocopies.
5. Reserved category candidates shall bring original reserved category certificates along with three sets of self-attested photocopies.
6. Admission Verification Form (Appendix – 6 of GGSIP University Admission Brochure).
7. Physical Fitness Certificate: All students shall be required to submit a Medical Certificate as given in Part – B in Admission Brochure 2022 (As per Appendix 5).
8. Undertaking by the student with respect to anti – ragging and undertaking by parent/guardian with respect to anti – ragging as per Appendix 7 & 8 of Admission Brochure for Academic Session 2022-2023 available on the university website.
9. Conduct and Character Certificate in original from the Head of the institution from where the qualifying examination has been passed or from Gazetted Officer (Original), not more than 6 (six) months old.

10. In case of gap year, the candidate is also required to submit a notarized Gap Year Affidavit on stamp paper of Rupees Ten along with one self – attested photocopy.
11. Candidate shall submit Undertaking that he/she has not taken admission and will not seek admission anywhere else in any college of affiliated to GGSIP University once the seat is allotted in management Quota.
12. Candidates who have already taken admission through online counselling shall not be eligible for consideration under M.Q. seats.
13. Candidates once admitted under Management Quota seat will not be eligible to take admission in any other college affiliated to GGSIPU.
14. All admissions are provisional subject to ratification by the University.
15. Seat Matrix for management Seats is also attached.
16. The candidates not carrying the above documents, shall be denied admission and shall have no right for the admission further. The seat in respect of such candidates will pass on to the next merit holder.
17. In the case of candidates seeking admission in the reserved categories, the candidates must present the relevant reserved category certificate for verification.
18. Conversion of reserved seats in to general category seats will be done in the 2nd round of counselling as per laid down procedure of the University.
19. Fee will be paid in favour of Jims Engineering Management Technical campus via Cheque or online banking as per university fee notification
20. Withdrawal will be done as per university guidelines
